I, the undersigned, agree as a condition of participation in any activity in this arena, to release save harmless, defend, protect, and indemnify any person and/or organization (including but not limited to the Potter Valley Community Expo, Inc., the directors of any of those corporations, all committees and sponsors, their representatives and successors) in any way associated therewith and there agents, members, officers, and directors from loss, damage or liability of any sort arising out of or in any way relating to my participation in said Parade, Rodeo, Roping, Drill Team, or Gymkhana activity. If the participant is a minor the undersigned parent or guardian acknowledges that they have read this Agreement and agrees to be bound by its terms as a releaser and as a guarantor and indemnitor of said persons and/or organizations and their agents, members, officers and directors, for the minor and in the minor's place and stead. I waive ALL RIGHTS which I now or may have by virtue of Section 1542 of the California Civil Code which reads: "A general release does not extend to the claims which a creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him, must have materially affected his settlement with the debtor"

I know that being in a rodeo can be a potentially hazardous activity. I assume all risks associated with this event, including but not limited to falls, injury to myself, my child, or my horse, etc. Having read this waiver and knowing these facts and in consideration of your accepting my entry. I, for myself or for my child and anyone entitled to act on my behalf waive and release the Potter Valley Community Expo, Inc., a California Non Profit Public Benefit Corporation, the directors and all sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation or my child's participation in the rodeo and other activities even though that liability may arise out of negligence or carelessness on the part of the persons/groups named in this waiver.
