Rules

- **Judges will make final determinations.**
- Each contestant including Sr. partners must send in an Entry Form with a signed Participation Agreement.
- Contestant must be 18 years old or younger as of May 26, 2018.
- Maximum of 25 riders for barrel racing, pole bending, goat tie and ribbon goat tie, 10 riders for rough stock events and 20 riders for all other events including sheep riding.
- Team Roping partners must be listed on entry form. If your partner is not listed, you will not be entered in that event. We will not find a partner for you.
- A random draw will determine go order. After names are drawn there will be no changes!
- A senior team roping partner must be over 18 years old and can only be entered two (2) times.
- Contestants must wear western attire. Long sleeve shirt, pants, boots and hat.
- Sheep riders must be 50 lbs. or less. Sheep riders will be weighed to ensure they do not exceed weight limit.
- Sheep and calf riders must have protective head gear that fits properly and appropriate equipment. We will not provide protective equipment.
- Rough stock and calf riding contestants must provide their own equipment. Protective vests are mandatory in all rough stock and calf riding events. We will not provide protective equipment.
- A mandatory meeting for contestants will be held 15 minutes prior to the start of slack and at performance. Attendance is required!
- All contestants shall comply with the rules. Any un-sportsman like conduct will result in disqualification. Judges will make the final determination.
- Grievance procedure: Contestants only, must address all questions or problems to the Arena Director. Judges will make the final determination.
- Entries close Monday, May 14, 2018. After this date there will be a three day grace period to sign up with an additional late fee of \$20 per contestant. Only post marked entries accepted - **NO phone entries or post entries.**
- Entries must be paid in full. Please make checks payable to: Potter Valley Rodeo

Monies: 1-5 entries= 1 money, 6-10= 2 monies, 11-15=3 monies, 16-20= 4 monies, 21-25= 5 monies.

Points: Points will be awarded to 1st - 10th place in each event. Points will be kept within age groups.

All Around Prizes: Prizes will be awarded in each age group. Saddles will be awarded to all around in each age division. You must be entered in at least 2 events to compete for all around.

*** All around awards winner must be present to receive. If not present, All-Around prize will be awarded to next highest point winner. Dress code must be worn for all contestants receiving awards.**

At the Potter Valley Parks and Recreation grounds, arena and parade areas

I, the undersigned, agree as a condition of participation in any activity in this arena, to release save harmless, defend, protect, and indemnify any person and/or organization (including but not limited to the Potter Valley Community Parks and Recreation, Inc., the directors of any of those corporations, all committees and sponsors, their representatives and successors) in any way associated therewith and there agents, members, officers, and directors from loss, damage or liability of any sort arising out of or in any way relating to my participation in said Parade, Rodeo, Roping, Drill Team, Woodcutting, Axethrow or Gymkhana activity. If the participant is a minor the undersigned parent or guardian acknowledges that they have read this Agreement and agrees to be bound by its terms as a releaser and as a guarantor and indemnitor of said persons and/or organizations and their agents, members, officers and directors, for the minor and in the minor's place and stead. I waive ALL RIGHTS which I now or may have by virtue of Section 1542 of the California Civil Code which reads: "A general release does not extend to the claims which a creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him, must have materially affected his settlement with the debtor"

I know that being in a rodeo can be a potentially hazardous activity. I assume all risks associated with this event, including but not limited to falls, injury to myself, my child, or my horse, etc. Having read this waiver and knowing these facts and in consideration of your accepting my entry. I, for myself or for my child and anyone entitled to act on my behalf waive and release the Potter Valley Community Parks and Recreation, Inc., a California Non Profit Public Benefit Corporation, the directors and all sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation or my child's participation in the rodeo and other activities even though that liability may arise out of negligence or carelessness on the part of the persons/groups named in this waiver.
